### CONSTITUTION AMENDED

By a vote of those present at the April 26 Meeting, the constitution of the Society was amended as proposed by Dr. John H. Smith of the nominating committee. The affected section of the constitution now reads:

"The President, Vice-President, and Secretary-Treasurer shall be elected at the annual meeting of the Society. At least two nominees for the offices of President and Vice-President and at least one nominee for the office of Secretary-Treasurer shall be proposed by a nominating committee appointed by the Executive Committee."

A majority acceptance of the meeting where the amendment was proposed, written notification to the membership, and majority acceptance at a second meeting were required to make this change in the constitution.
