SCIENTIFIC AND PROFESSIONAL PERSONNEL
A NATIONAL CRISIS?

ANNUAL MEETING AND ELECTION

As described in last month's NEWS LETTER, the recent constitutional amendment provides for balloting by mail. If you are a paid-up member of the Washington Statistical Society you will find enclosed a ballot and a return envelop. To be counted, ballots should be returned to the ASA office by 5 p.m. Monday, May 23 or delivered in person at the Annual Meeting by 8 p.m. An early return by mail will be appreciated by the Nominating and Elections Committee.

If you have not yet paid your 1955 dues, but do so before May 23, a ballot will be mailed to you. If you believe you should have been mailed a ballot, but failed to receive one, please call the ASA office, EX 3-3253.

The Constitution provides that the Nominating and Elections
Committee shall conduct the election. This Committee, composed of Ezra
Glaser, Selma Goldsmith and Joseph Steinberg, has ruled (in the absence of
a constitutional provision on the point) that a plurality, not necessarily
a majority, is sufficient to elect the President, Vice-President and
Secretary-Treasurer. The Constitution provides that "the three candidates
for Elected Member of the Executive Committee who receive the most votes
shall be deemed to have been elected."
