#### PHYSICAL SCIENCE AND ENGINEERING PROGRAM

In recent years statisticians have become increasingly concerned with the meaningful formulation and solution of certain multiple-decision problems which arise in experimentation. Thus, for example, when an experimenter conducts tests to compare the performances of several competing categories of items, his ultimate objective often is to select the category (or categories) which is (are) best, goodness being measured in terms of a particular parameter (e.g., the population mean or the population variance) associated with the random variable being observed. To accomplish this, the experimenter requires a statistical decision procedure which will tell him how many observations to take, how to take these observations, and based on these observations, which population(s) to choose; the decision procedure should have the property that the probability of an incorrect solution (or more generally, the risk or expected loss) is controlled at some specified level. In response to the need for such decision procedures, research statisticians have been studying various possible appropriate formulations of these problems, and have developed a body of statistical methodology to cope with them. The procedures have come to be referred to as "Ranking and Selection Procedures." The purpose of this talk is to introduce these procedures, to describe some of them, and the philosophy underlying their use, and to discuss their properties.

Work Experience: In addition to the education requirements, a candidate to be qualified for this position must have at least 1-3 years of specialized experience (education may be substituted). Experience should include evidence of professional statistical work such as sampling, collecting, computing and analyzing statistical data; applying known statistical techniques to data such as measurement of central tendency, dispersion, sampling error, simple and multiple correlation, analysis of variance and tests of significance.

## President's Annual Report, 1974-1975

## Program Activities

In this, the 49th year of the Washington Statistical Society, 32 program sessions were held, to which all of the Program Committees contributed, making this the most active program year the WSS has ever had. Four of the programs were jointly sponsored by two Program Committees and four of the programs were jointly sponsored by the WSS and other organizations. There was one luncheon meeting but no evening meetings.

Three programs covered areas of interest to all Program Committees generally, and were sponsored by the Board of Directors. These were the luncheon meeting reviewing the election results (November), the local public meeting on 1980 Census Needs cosponsored with a number of other local organizations (March), and the panel discussion on the effect of privacy and confidentiality legislation on federal statistical programs (May).

At the annual dinner, Albert Rees, Director of the Council on Wage and Price Stability, spoke to the Society on "Use of Statistics in Wage-Price Monitoring."

# Organizational Activities

The Committee on Revision of the WSS Constitution and By-laws (Margaret Martin, Chair, Benjamin Tepping and Theodore Woolsey) submitted a recommended new constitution and by-laws. With some minor revisions by the Board of Directors, the revised constitution was sent to the membership and approved by a vote of 345 to 7.

The Board of Directors agreed that the WSS will act as host for the 1979 Annual Meeting of the American Statistical Association, which will be held at the Washington Hilton Hotel on August 13-16. A Local Arrangements Committee will be appointed later to assist in the planning and operation of this meeting.
