The Failure Rate Function is one of the most important parameters in reliability theory and in biometry. We propose a simple estimator of the failure rate function, and investigate its properties. Our estimator is easy to compute, is unbiased, but is inconsistent. We smooth our estimator by a smoothing window and investigate the conditions under which the smoothed estimator is consistent and unbiased.

President's Annual Report, 1975-1976

Program Activities

This year is the 50th anniversary of the establishment of the Washington Statistical Society. In commemoration of the occasion, the Annual Dinner was dedicated to a salute to the Society. Jerome Cornfield, A. Ross Eckler, Churchill Eisenhart, Morris Hansen, and Aryness Joy Wickens, all past presidents of the American Statistical Association and also members of the Washington Statistical Society, spoke on "The Past as Prologue to the Future." A record 158 people attended the dinner, and many more, who called at the last minute, could have enjoyed this outstanding occasion had they made their reservations in time to be included in the guarantee to the caterer. One of the speakers, Morris Hansen, had been elected to membership of the National Academy of Sciences only a short time before, adding additional distinction to the celebration.

During the year, 37 program sessions were held, topping the previous high of 32 held during the 1974-75 season. Of the total, 13 were sponsored or co-sponsored by the Methodology Section—by far our most active. The Society had no luncheon or evening meetings this year.

The Society was invited to participate in an appropriate observance of the 75th anniversary of the National Bureau of Standards. A committee consisting of Barbara Bailar, David Hulett, and Joseph Steinberg was appointed to work with the NBS in making appropriate plans.

Organizational Activities

In accordance with the constitution and bylaws for the Society adopted last year, procedures were approved for a "local associate" category of membership. This category will consist of members in the Society who are not also members of the ASA. The purpose of the new category is to reach nonmembers who may be willing to join the local Society but are not interested in national membership. Hopefully, through association with the WSS, these members will, after a while, also affiliate with the ASA.

The Board also approved a proposal to allow the ASA members who do not live in the Washington area to join the WSS as out-of-area members.

The May meeting of the Board of Directors was designated as an open membership meeting and members were invited to attend and raise any comments or suggestions concerning Society activities.
