The Employment Cost Index (ECI), now being developed by the Bureau of Labor Statistics, will provide a comprehensive measure of change in rates of employee pay.

The second paper discusses the survey design, including sample selection, estimation procedures and variance estimation. The sample is selected in stages, the final stage involving the use of two-way controlled selection.

President's Annual Report 1978-79

Program Activities

A total of 36 program sessions, including four luncheon sessions were held during the year. Four of these were cosponsored presentations. Cosponsors included the National Bureau of Standards and the George Washington University Departments of Statistics and Operations Research. Program sessions normally attracted audiences of 30 to 50 but there were several with audiences of 70 to 75 and a number with audiences exceeding 100.

One of the largest audiences of the year was for the C.R. Rao session cosponsored with the George Washington University Department of Statistics and held on the GWU campus. This was one of the few events during the year attended by a large number of students.

Dr. Fred Leone's official "visit" to WSS for a luncheon meeting in January was a lively session. Fred suggested that this would be a good time for our chapter to evaluate its activities and a review committee has been appointed based on his recommendation. We expect to receive recommendations from the committee later this year.

A luncheon meeting in May featured Professor George E. P. Box, immediate past President of ASA, who spoke on "Sampling and Bayes' Inference in the Advancement of Learning."

The Society held its annual banquet on June 7 at Fort McNair, with Vincent Barabba, Director Designate of the Census Bureau, as principal speaker. Barabba's talk, which made use of some highly sophisticated visual aids, emphasized the need for Federal statisticians to improve communications with data users in order to serve their needs more effectively.

A major innovation for WSS this year was its sponsorship of 6 summer meetings, held on consecutive Tuesdays, starting on June 19. These meetings were primarily designed to provide summer employees of statistical agencies with a broad picture of the history and current status of Federal statistical programs and institutions, and to let them hear several distinguished Federal statisticians talk about their work. Attendance at the 6 meetings ranged from 30 to 70. Over 160 persons, representing more than 25 different organizations attended one or more sessions.

Organizational Activities

A significant new activity this year was the establishment of the Washington Statistical Society Award in memory of Julius Shiskin. This Award, to be given periodically for an outstanding achievement in the field of economic statistics, will honor this distinguished public servant who died on October 28, 1978. The major organizations with which Julius Shiskin was associated will join WSS in the selection of Award recipients. The first Award is planned for 1980.

Representative at Large Dick Taeuber took the lead in arranging a special invited paper session at the 1979 American Statistical Association Annual Meetings in Washington. The topic for this WSS sponsored session was "Statistics and the Press".

In order to assure a reasonable distribution of duties and responsibilities among the officers of WSS, the Board decided, late in 1978, to split the offices of secretary and treasurer. This new arrangement, permitted by our constitution, is working well.

The WSS this past year joined the National Council of Associations for Policy Sciences (NCAPS). It is hoped that this new affiliation will enable WSS to take advantage of programs sponsored by other member organizations, and to participate in more jointly sponsored meetings.

Confirming an arrangement used on an experimental basis in the preceding year, at the joint board meeting in July 1978, the by-laws were amended to transfer responsibility for the WSS Newsletter to the publicity chairperson. During the 1978-79 program year, 10 monthly issues were mailed to the membership, the final one being the announcement of the summer program in the June 1979 issue. During the program year, in order to combat increased mailing costs, the Newsletter was converted to a self-mailing format. Some mailing list problems were encountered as the result of conversion of the national ASA membership lists to a new system; we believe these problems are now largely resolved.

At the suggestion of President-elect George Hall, a new committee was established early this year to investigate the need for and feasibility of providing technical assistance on statistical matters to local government units in the Washington Methropolitan Area. The Committee, which is chaired by Richard Taeuber, has already received several positive expressions of interest from local government officials.

WSS also assisted the national ASA office in establishing a Local Arrangements Committee for the 1979 Annual Meetings. The Local Arrangements Committee, chaired by James O'Brien, has exercised its very substantial responsibilities independently of the WSS Board. However, WSS provided assistance in recruiting members for the Committee and, of course, it is staffed largely by members of WSS.

Awards

The Society awards a year's membership in the ASA and the WSS to outstanding graduate students nominated by local universities. This program is designed both to provide recognition to outstanding students and to direct their attention to the field of statistics. This year's recipients were:

ANNOUNCEMENT


