The Universal Social Security Coverage Study Group has conducted a two-year study on the feasibility and desirability of extending Social Security coverage to Federal and uncovered State and local employees. At this session, members of that group will present papers on some of the issues which have been addressed and findings which have been made and forwarded to the Secretary of HEW for submission to the Congress. The rationale for considering the extension of coverage, ideas on alternative programs, and possible effects of implementing

different plans will be considered.

Abstract:

Methods Tests Panel was selected to test alternate data collection methodologies and concepts for use in the CPS. Three experimental treatments were considered: interview mode (telephone vs. personal); respondent type (self vs. proxy); and interviewer assignment (same vs. alternate interviewers). The report examines the effect of each treatment and their interactions as they affect the estimated unemployment

rate. A fourth issue, Rotation group bias, is also discussed.

The NCHS has been involved in many of these activities. In this seminar, we will present a review of the trends in infant mortality in DC and discuss the conduct of a study using DC's file of linked birth and infant death records. Particular attention will be focused on the

role of birthweight in determining neonatal mortality.

The Consumer Price Index (CPI), the Nation's most important price index, has been used for a variety of purposes such as a measure of change in purchasing power and as a basis for indexation of wages and pension benefits. Although the index serves users both during periods of relative price stability and in periods of rising or declining prices, questions about the accuracy of the measure peak in periods like the present, when prices tend to be unresponsive to measures taken to diminish their rapid rise. In this session, the adequacy of the CPI as a measure of inflation and the cost of living will be discussed. Such questions raise the issues of the treatment

of homeownership and the use of a fixed market basket.


